AECM – The European Association of Guarantee Institutions

Founded in 1992 by 5 members from

- Belgium, France, Germany, Italy & Spain

In 2016

- 41 members in 25 countries (21 = EU)

Total volume of outstanding guarantees (end of 2015)

- approx. 81 billion EUR

New production in terms of volume in 2015

- approx. 29 billion EUR

AECM – The European Association of Guarantee Institutions

Total number of outstanding guarantees (end of 2015)

- approx. 3 million guarantees

New production in terms of number in 2015

- approx. 700.000 guarantees

Range of average size of guarantee in portfolio (end of 2015)

- Austria: 163.000 €
- Turkey: 7.800 €

Range of member size in volume (end of 2015)

- Italy: 41,72%
- Luxembourg: 0,00%

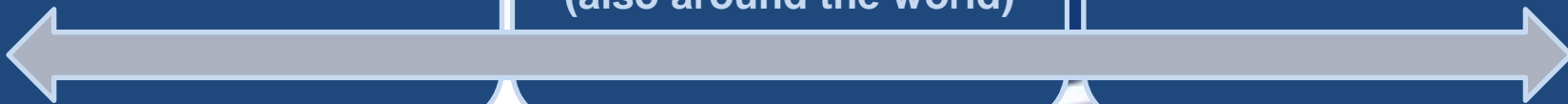

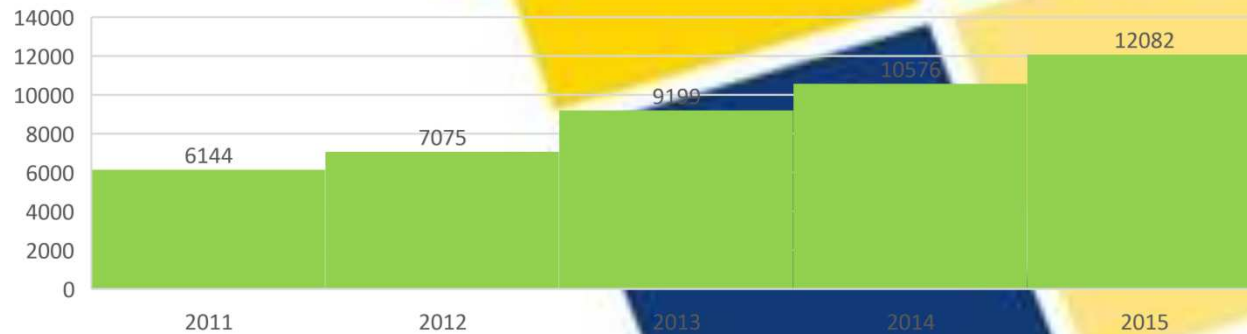

(in units)**



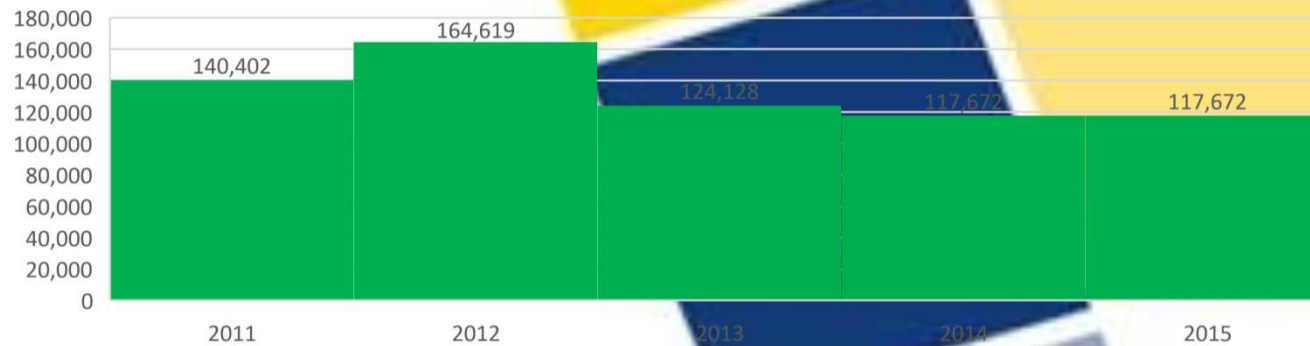

(in '000€)**



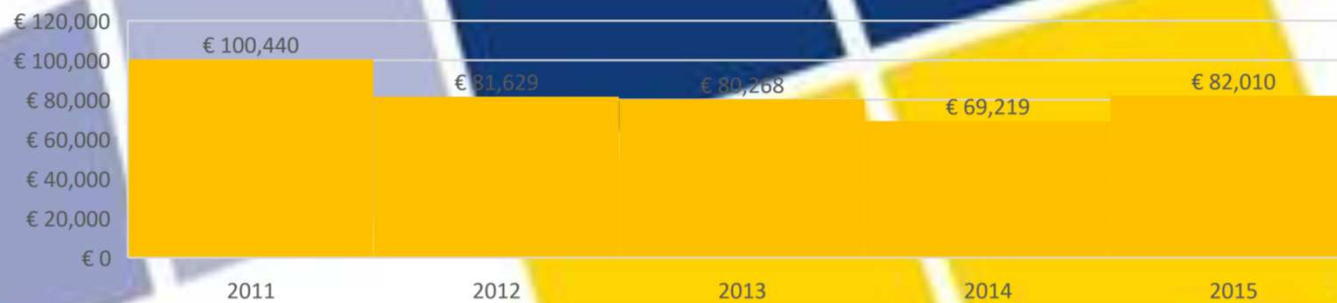

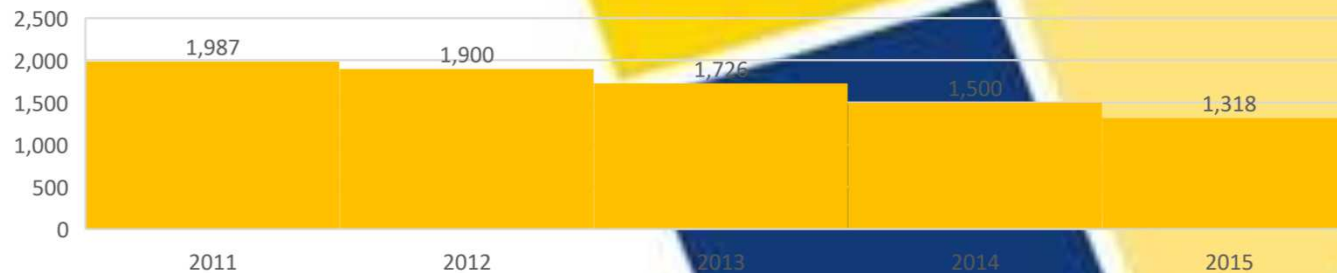

(in '000€)**



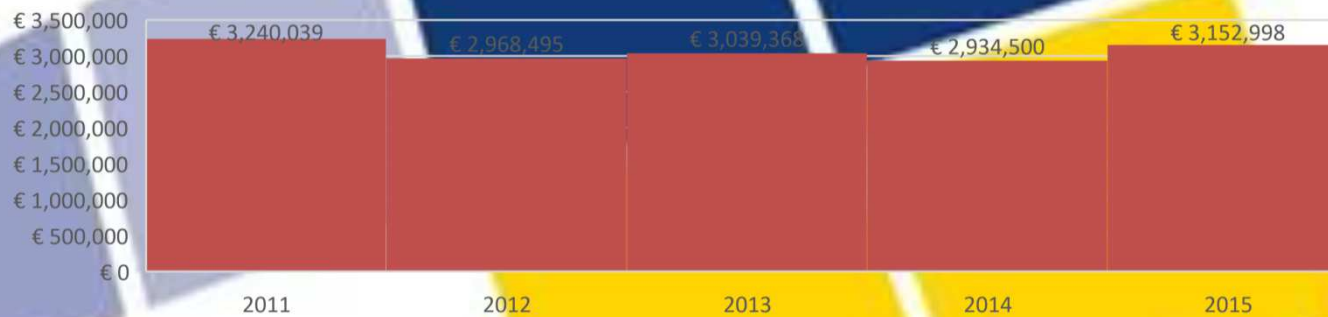

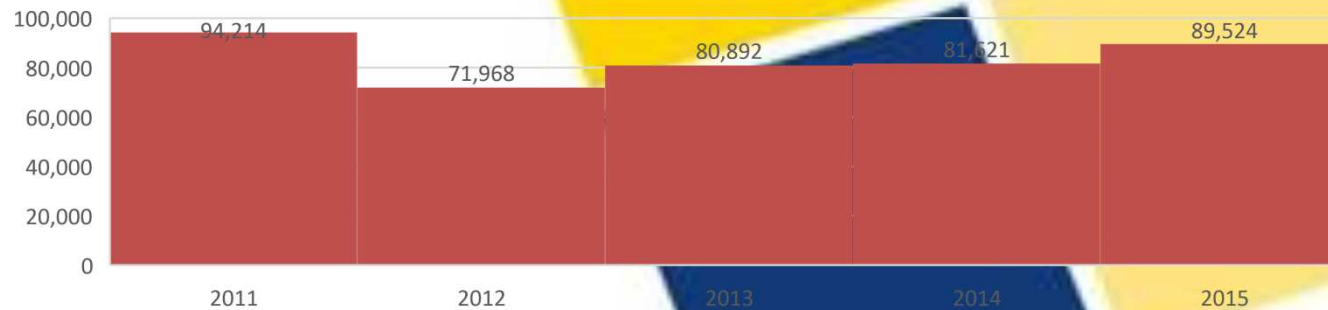

Total volume of outstanding guarantees (in portfolio) Agrogarante (POR) (in '000€)



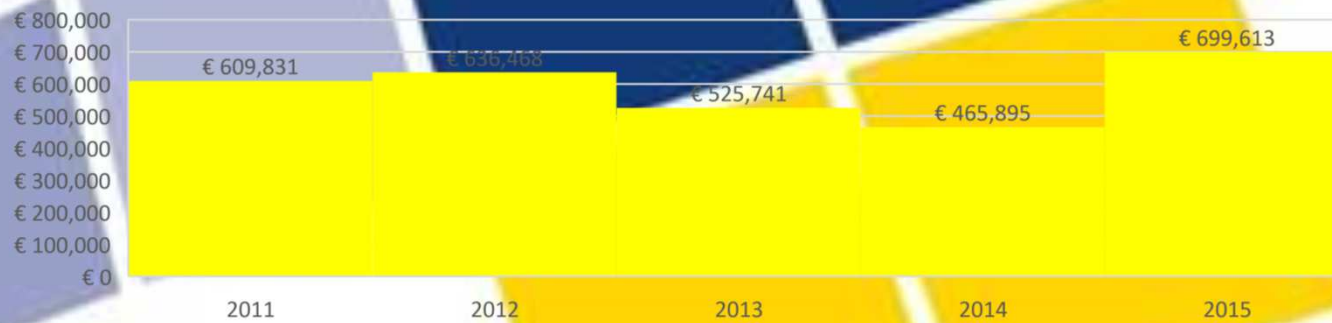

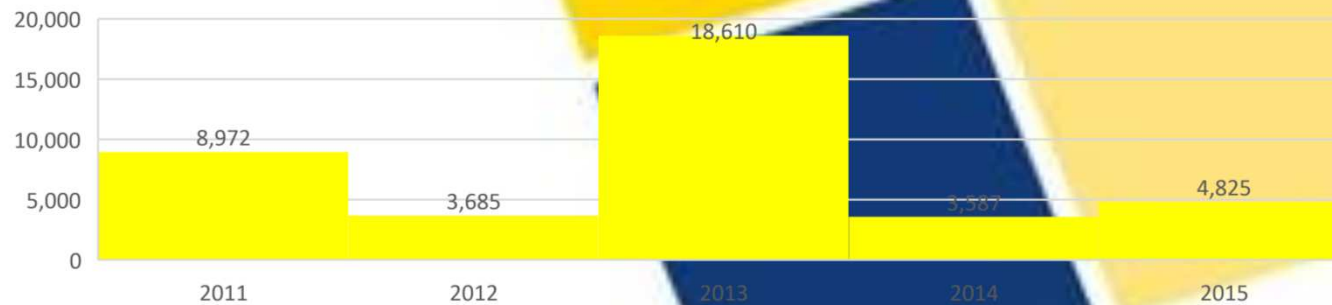

Total number of outstanding guarantees (in portfolio) FGC-Rural (ROM) (in units)



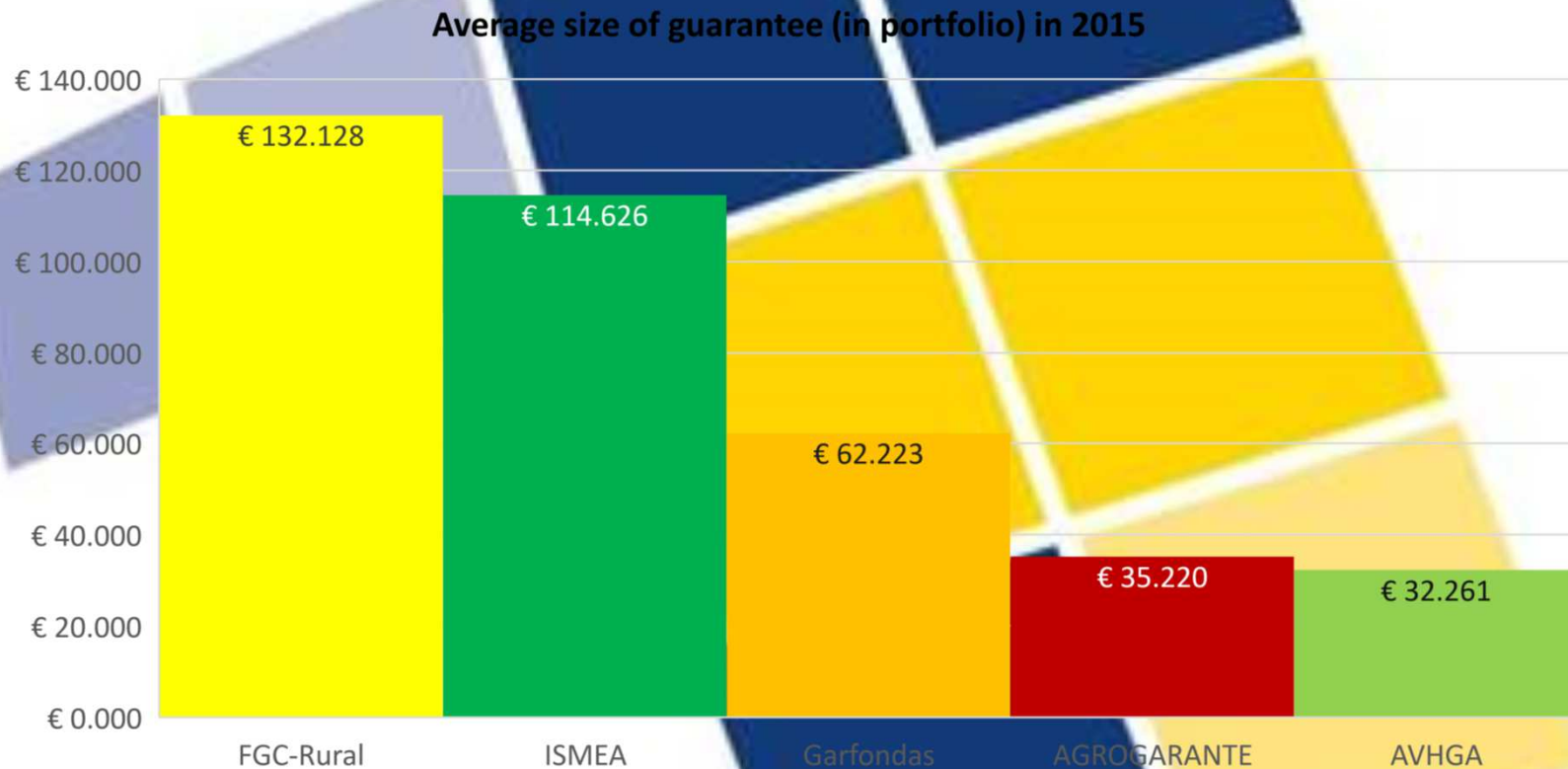
AECM – Member Statistics

AECM's statistics of members working in the agricultural sector:
maximum guarantee coverage

- AVHGA (HUN) → guarantee of up to 80%, max. 2.5 mio. €
- ISMEA (ITA) → guarantee of up to 70%, max. 1 mio. € (micro and small enterprises) / 2 mio. € (medium-sized enterprises)
- Garfondas (LIT) → guarantee of up to 80%, max. 1.6 mio. €
- AGROGARANTE (POR) → guarantee of 50% to 75%, max. 1.5 mio. € to 4.5 mio. €
- FGC-Rural (ROM) → guarantee of up to 80%, max. 2.5 mio. €
